**No-18/Pra-shu-mi-04-06/2025** -----**17373**/ Under the Good Governance Programme, the State Government is continuously working with transparency on administrative reforms, capacity building, innovation etc. In the above sequence, by associating young subject experts with decision making authorities at various levels of policy making and administration and the officials implementing the policies and decisions of the government, keeping in view their expertise and experience, there will be evidence-based capacity building of talented youth related to the implementation of public policy formulation and implementation and the participation of youth will provide new energy and momentum to the implementation of government policies and schemes.

2. In the above context, the Chief Minister's Fellowship Scheme is approved. The total estimated expenditure on this two-year scheme is Rs. 31,85,88,900/- (Rupees Thirty one crore eighty five lakh eighty eight thousand and nine hundred) only Which will be under the budgetary provision of the General Administration Department

3. The objective of the Chief Minister's Fellowship Scheme is to associate high quality experienced subject experts at various levels of administration for a period of two years. These subject experts will assist the decision makers in policy formulation and implementation of state interest schemes, Innovation etc. in district, division, department and state level major offices and will accelerate the development of Bihar by acting as a catalyst in the above sequence.

4. The main features of the said scheme are as follows:-

- I. This scheme will be implemented by the General Administration Department in collaboration with IIM, Bodh Gaya
- II. The period of Fellowship will be for 2 years, during which the selected Fellows will be paid a fixed monthly honorarium amount.
- III. On successful completion of the two year period, a certificate in Public Policy and Good Governance will be awarded by IIM, Bodh Gaya.
- IV. This scheme will be for the native residents of Bihar.
- V. The maximum age limit for subject experts of different levels and experience will be determined in the light of the resolution/order issued by the General Administration Department. The prevailing reservation rules of the State Government will be applicable
- VI. A total of 121 Fellows will be selected in collaboration with IIM, Bodh Gaya and they will be attached to each Municipal Corporation, District Collectorate, Divisional Commissioner's Office, all departments of the Secretariat, Development

Commissioner, Chief Secretary, Deputy Chief Minister's Office and Chief Minister's Secretariat. It's detailed description is as follows.

5. Total Expenditure of Rs. 31,85,88,900/- (Rupees Thirty One Crore Eighty Five Lakh Eighty Eight Thousand Nine Hundred only) is estimated on the implementation of the said two-years fellowship scheme. This includes IIM BodhGaya fee of Rs-3,50,98,000/- (Rupees Three Crore Fifty Lakh Ninety Eight Thousand only) and administrative assistance fund of Rs. 1,51,70,900/- (Rupees One Crore Fifty One Lakh Seventy thousand and Nine Hundred only)

6. The General Administration Department will be the Nodal department for the implementation of this scheme, and will issue detailed guidelines from time to time regarding this scheme. For the Successful implementation of this Two-years fellowship scheme, General Administration Department will sign an agreement (MoU) with IIM BodhGaya. General Administration Department will be able to take a decision to continue this scheme further by assessing its success/ impact.

The Implementation of the above scheme and expenditure of the above amount, the detailed operational guidelines of the scheme will be finalized by the General Administration Department after consultation with IIM, BodhGaya, in which the General Administration Department will be competent to make amendments as per the requirement from time to time.

8. The Chief Minister's Fellowship Scheme is approved in the meeting of the council of Ministers dated 09-09-2025 as item no.-10.
